1. Introduction:

Baroda U.P. Bank invites tenders from eligible vendors for a Comprehensive Annual Maintenance Contract (CAMC) for UPS Systems across its branches and offices.

2. Contract Period:

The contract will be effective for a period of one (1) year, commencing on Nov 21, 2024, and ending on Nov 20, 2025. The bank may, at its sole discretion, extend the contract for additional terms upon mutually agreeable terms.

3. Scope of maintenance:

This contract covers comprehensive onsite maintenance for all UPS Systems listed in the bank's inventory.

4. Maintenance Services:

The maintenance service includes both preventive and corrective maintenance.

- **4.1 Preventive Maintenance:**
 - On quarterly basis. Includes:
 - Cleaning internal components.
 - All measures should be carried out for proper functioning of all UPS systems.
- **4.2 Corrective Maintenance:**
 - Repair or replacement of faulty parts of UPS System.

4.4 Replacement Parts:

- The vendor shall provide replacement parts at their own cost. Parts must be:
- Original equipment manufacturer (OEM) parts for the specific brand and model of the equipment.
- Alternatively, high-quality compatible parts from reputable brands, with prior bank approval.
- Stocked on-site or readily available for prompt replacement (within 48 hours for critical components, and within a reasonable timeframe for non-critical components).
- Replacement parts provided by the vendor will carry a warranty of 6 months against manufacturing defects.

5. Technical Staff:

- The vendor shall provide two (2) dedicated resident engineers for on-site support.
- Engineers should be available during all bank working/non-working days as per requirement to respond to service requests from branches/offices.
- In case of an engineer's unavailability, the vendor must provide a replacement engineer promptly.

6. Vendor Responsibilities:

- The vendor is responsible for ensuring the satisfactory operation of all covered UPS Systems throughout the contract period.
- The vendor is also liable to rectify any damaged identified after the contract expiry if proven to be caused by the vendor's negligence during the contract period.

7. Communication and Reporting:

- The vendor will establish a single point of contact for the bank's IT department and branches for efficient communication and complaint tracking.
- The vendor will provide weekly reports to IT Department Ghazipur containing details on:

- New and pending service requests.
- Complaint details (complaint number, date/time, nature of complaint, etc.).
- Engineer visit details (date, time, and branch verification report).
- Current status of each complaint.
- Date of complaint resolution.
- Call Tracker with Ageing, Status, Call logged/Disposed etc Details.

8. Response Times & Penalty:

- Critical service requests (e.g., system outage affecting core banking operations) will be acknowledged immediately and resolved within 6 hours during business hours.
- Non-critical service requests will be acknowledged & resolved within 24 hours.
- Any parts that need to be changed/repair should be done within 3 days.
- Failing to comply with above TAT, Rs. 100/- per day penalty will be levied (From registered time of complaint by branches/offices.)

9. Escalation Process:

- Unresolved service requests will be escalated to the vendor's designated escalation point for further action.
- The contract will define clear escalation timelines & matrix for various issue severities.

10. Bank reserves the right to:

- Reject any and/or all responses received in response to the RFP
- Waive or change any formalities, irregularities, or inconsistencies in proposal format delivery.
- Extend the time for submission of the tender.
- Withdraw, postpone or Cancel the tender at any stage, without assigning any reason whatsoever.
- If complain call will be delayed by more than one weeks from the date of complain, bank will have right to cancel the CAMC.

11. The competent Authority (Bank) does not bind themselves to accept the lowest or to give any reasons for its decision of acceptance or rejection of tenders.

12. Conditional tenders shall not be accepted on any ground and shall be rejected straight away.

13. Any deviation of the conditions laid by the bank will not be accepted and the bid will be rejected without assigning any reasons.

14. Earnest Money Deposit:-

Earnest Money Deposit (EMD): Earnest Money Deposit of Rs. 25,000.00 {Rupees Twenty-Five Thousand Only} has to be submitted by the way of Demand Draft I Banker's Cheque/ Pay Order drawn in favour of "Baroda UP Bank" payable at Regional Office, Ghazipur. Earnest Money Deposit will not carry any interest.

- The Earnest Money Deposit of unsuccessful bidders will be refunded accordingly in due course.
- The Earnest Money Deposit of the successful bidder shall be refunded one month after successful completion of CAMC tenure subject to renewal of CAMC if any.
- Under the Government guidelines "Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2018" interested MSEs firms may submit their quotation with all relevant documents and valid certificate for relaxation of EMD.
- The selected bidder will have to deposit Rs.10000/- (Ten Thousand Rupees only) with our bank as security money. The selected bidder will have to sign an agreement with the bank. No interest will be paid on security money.

The Earnest Money Deposit will be forfeited if:

- If successful bidder withdraws from the CAMC before completion of CAMC period/tenure then Bidder must inform the bank and would need to provide service for minimum period of 3 months from the date of given letter.
- The bidder withdraws his tender after processing but before acceptance of "Letter of appointment" to be issued by the Bank.
- The bidder violates any of the provisions of the terms and conditions of this TENDER specification.
- Earnest Money Deposit will be refunded for the unsuccessful bidders within one month from the date of opening of bids.

15. Eligibility Criteria for Bid Submission

- Duly Filled Annexure-I: This includes supporting documents or certified copies that demonstrate your company's compliance with the eligibility criteria outlined in Annexure-I.
- Self-Declaration Letter: The bidder must submit a letter on company letterhead stating the company has not been blacklisted by any public sector Bank/PSU/ Government department in past.

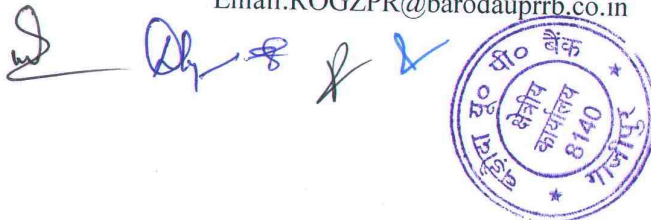
