ELIGIBILITY:

- > Only those vendors who have minimum Three-year experience of AMC of UPS in PSU's, Government organizations/Private banks/Engineering colleges etc. (attach copies of service allotment and satisfactory service letter from institution).
- > The Bidder must have local service support office at Raebareli.
- ➤ The Firm/Company should not have been blacklisted by any public sector/ Bank /PSU/Government Department in the past. A self-declaration letter by the bidder, on the company's letter head should be submitted along with bid.
- > The firms/companies must have been registered with Goods & Service Tax Department for work contract and shall provide PAN/GSTIN No. with the bid.
- > Firms managing AMC/CAMC of UPS system in BUPB need to provide satisfaction letter from concerned region.

VALIDITY OF RATES:

- The contract will be effective for a period of one year and may be renewed if services are satisfactory on expiry for further period of one next year on previous rates.
